## **Methods and material for containment and cleaning up:**

Dike far ahead of larger spill for later recovery and disposal. Pick up free liquid for recycle and/or disposal. Residual liquid can be absorbed on inert material. If liquid is too viscous for pumping, scrape it up. Collect for salvage or disposal. Wash area with soap and water. Spilled liquid and dried film are slippery. Use care to avoid falls.

## **7 HANDLING AND STORAGE**

Precautions for safe handling: Observe good industrial hygiene practices. Provide adequate ventilation. Wear appropriate personal protective equipment. Avoid prolonged or repeated contact with skin.
